President's Report: Dan reports that the Maintenance contract with Pruning Pros has been terminated by WPCA. Our contract is now with Jimmie's Lawn and Landscape Services LLC.

WPCA has received payment of \$7,771.92 from Koselka DeVine, PLC, from PEA relieving them from law suit relative to legal issues. Our attorney is still working with Dan regarding the issues with Pinckney Community Schools and the flooding of our retention ponds.

An insurance claim was filed pertaining to the hail storm damage done on May 29, 2105. Damage was done to the Whispering Pines Drive fountain and the gazebo roof. Reimbursement checks from the Insurance Company total \$2,045.00. On October 1, 2015 the gazebo roof was replaced.
