Thank you to the WPCA Board members and the homeowners who attended the school meeting. We need to have your continued support. You also may have noticed the week before Christmas, that there was a pump put in the Whispering Pines Drive retention pond to help lower the water level. Any rain/snow continues to change these levels day to day. Thanks John for helping us monitor this also! Dan and Roxanne were contacted by the Brighton/Argus and met with a reporter and photographer this week who will be doing an article soon.

Dan and John have also asked that homeowners check along the curb edge and the drains to be sure they are clear of debris. Thanks!

Secretary's Report: With the Arbitration ruling to remove the speed bumps on Whispering Pines Drive, it makes the safety issue at this intersection even more important. Last week Roxanne met with Pat Hohl the Hamburg Township Supervisor, Richard Duffany Hamburg Township Police Chief and Jim Neilson Hamburg Township Clerk. WPCA continues to be concerned about our residents and/or visitors and are looking at various ways to ensure everyone's safety.
