### CONTRACT FOR VEHICLE CODE ENFORCEMENT

This contract is made by and between HAMBURG TOWNSHIP, a Michigan Municipal Corporation, ("Township"), 10405 Merrill Road, P.O. Box 157, Hamburg, Michigan 48139 and Whispering Pines Condominium Association ("Owner"), as follows:

#### RECITALS

**Whereas**, Township is a Michigan Municipal Corporation which operates and maintains the Hamburg Township Police Department; and

**Whereas**, Township by appropriate ordinance, has adopted by reference the so-called Michigan Vehicle Code (Vehicle Code) MCL 257.1 et. seq.; and

**Whereas**, Owner owns or is in charge of private roads and/or private parking as well as parks and common areas described as follows:

Whispering Pines Drive  
Fairway Drive  
Rolling Greens Drive  
Mulligan Drive  
Meadowcrest Court  
Tree Tops Drive

**Whereas**, Owner is duly authorized to enter into this Contract;

**Whereas**, this contract is being made pursuant to MCL 257.951 et. seq.

**Now, Therefore**, for mutual considerations hereby acknowledged the parties agree as follows:

1. The parties agree that the Hamburg Township Police Department is hereby authorized to and will enforce the provisions of the Michigan Vehicle Code and Hamburg Township ordinances on all of the private roads or private parking lots, together with any parks and common areas located within the subdivision or condominium project described above.
2. The Hamburg Township Police Department is further authorized to and agrees to issue any and all tickets and/or citations deemed necessary in order

to properly enforce the ordinances of Hamburg Township and statutes of the State of Michigan as set forth herein.

3. The parties agree that the Hamburg Township Police Department may enter upon all of the area specified herein that are private yet open to the general public in order to enforce the provisions of the ordinances and statutes as specified herein.
4. The parties further agree that any necessary signage relating to the enforcement of the ordinances or statutes shall be made and posted on these areas at the sole cost and expense of the Owner.
5. This Contract cannot be amended or modified except by written agreement signed by all parties and shall be binding on the successors and assigns of the parties.
