ELEVENTH AMENDMENT TO THE MASTER DEED
PERTAINING TO EXHIBIT C
WHISPERING PINES CONDOMINIUM ASSOCIATION
ACT 59, PUBLIC ACT OF 1978, AS AMENDED

Section 9, paragraph (d) of the By-Laws of Whispering Pines Condominium, recorded at Liber 1308 Page 0816, Livingston County Records, has been amended by greater than 67% majority affirmative ballot votes of the co-owners.

Exhibit C, Protective Covenants

Delete paragraph (d) and replace it with the following:

- (d) Units that are adjoining the Golf Course.
 - Applicable to lots # 7, 8, 16, 17, 30, 45-48, 53, 56-58, and 81-91.
 - Lot # 57 and 58, become effective upon sale by current owners.
 - Golfers may enter the yard to retrieve their golf balls.
 - Golfers are to maintain a minimum of 25' from the Home or Decks.
 - Golfers are not allowed to drive their Golf Carts or bring Golf Bags into the yard.
 - Golfers are to ask permission to enter and retrieve their ball, if a person is present in the yard.
 - The ball is out of bounds and Golfers are not allowed to play their lie within the yard.

All By-Laws not amended herein shall remain in full force and effect.

This amendment to the By-Laws shall become effective upon recording with the Livingston County Register of Deeds.
